**All other pretrial motions must be filed and heard by the Court on or before the Friday prior to trial. A MOTION FOR CONTINUANCE CAN ONLY BE GRANTED BY THE JUDGE, EVEN IF AGREED.**

**ALL OBJECTIONS TO EXPERT WITNESSES AND/OR MOTIONS TO EXCLUDE EXPERT TESTIMONY – INCLUDING KELLY/DAUBERT/ROBINSON MOTIONS MUST BE SCHEDULED AND HEARD AT LEAST 10 DAYS PRIOR TO THE DATE OF TRIAL.**

**LAST MINUTE DESIGNATION, SUPPLEMENTATION, ETC. WILL NOT BE CAUSE FOR AN EXCEPTION TO THIS RULE.**
