A tax rate of \$0.58496 per \$100 valuation has been proposed by the governing body of Potter County.

The no-new-revenue tax rate is the tax rate for the 2024 tax year that will raise the same amount of property tax revenue for Potter County from the same properties in both the 2023 tax year and the 2024 tax year.

The voter-approval tax rate is the highest tax rate that Potter County may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that Potter County is not proposing to increase property taxes for the 2024 tax year.

A PUBLIC MEETING TO VOTE ON THE PROPOSED TAX RATE WILL BE HELD ON September 09, 2024 at the Potter County Commissioner's Courtroom, 350 SE 6th St. Ste 2141, Amarillo, Texas 79101.

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, Potter County is not required to hold an election to seek voter approval of the rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Commissioner's Court of Potter County at their offices or by attending the public meeting mentioned above.

## **State Criminal Justice Mandate**

The Potter County Auditor certifies that Potter County has spent \$21,970 in the previous 12 months for the maintenance and operations cost of keeping inmates sentenced to the Texas Department of Criminal Justice. Potter County Sheriff has provided Potter County information on these costs, minus the state revenues received for the reimbursement of such costs. This increased the no-new-revenue maintenance and operations tax rate by \$0.00022/\$100.
